Masks

- -As per the CDC's guidelines, masks are to be worn at the dancer's discretion
- -If you are exhibiting symptoms of a common cold, and do NOT have a fever, please wear a mask.



Cleaning

- -Surfaces such as barres, light-switches, doorknobs and high touch areas will be disinfected regularly
- The studio will be regularly cleaned



Hand Sanitization

- Bring your own hand sanitizer
- Hand sanitizer will be available in the hallway and in the studios
- Wash hands frequently



Safety Measures

LWB is operating under the NYS guidelines and procedures for safety



Dance bags

- Personal items (dance bag, jacket, foot wear, etc) will be kept in the studio of the class being taken.
- A marked spot will be available for dancers to place personal belongings



Foot Wear

 Street shoes must be taken off before entering the studio. (In winter months, boots can be left on the mats by the front door)

Assumption of the Risk and Waiver of Liability Relating to Coronavirus COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Health Check Procedures

LWB is committed to providing a safe, clean environment for every dancer who attends our studio. LWB is abiding by NYS regulations and guidelines for health and safety.

Thank you for joining with us to create a safe experience for your dancer!!

All students, with the help of their parents, should do the following:

- Determine if the dancer has been in close contact with a person who has been diagnosed with, tested for, or quarantined as a result of COVID -19 in the past 14 days. If so, please do not attend until after 10 days.
- Daily self monitor for symptoms i.e. (fever, cough, shortness of breath, diarrhea, fatigue, headache, muscle aches, nausea, loss of taste or smell, sore throat, vomiting, etc)
- If symptoms appear in alignment with COVID-19, we ask that you stay home, take the COVID-19 test, and report the outcome to us. No refund will be given for missed classes due to sickness.
